

## TERMS AND CONDITIONS FOR THE CHINESE NEW YEAR EVE SPECIAL 2026

1. The “Chinese New Year Eve Special 2026” programme (the “**Programme**”) is organised by Mediacorp TV Singapore Pte Ltd (“**Mediacorp**”) and will take place from 8.30pm on 16 February 2026 until 0100am on 17 February 2026 at Studio 1, Mediacorp Campus, 1 Stars Avenue Singapore 138507 (the “**Venue**”).
2. These Terms and Conditions shall apply to the activities and Games taking place during the live recording of the Programme (the “**Games**”). Employees of Mediacorp and all subsidiaries of Mediacorp and their immediate family members (including spouses, children, parents, brothers and sisters) are not eligible to participate in the Games.
3. All eligible audience members and viewers participating in any of the Games shall be referred to as “participants” in these terms and conditions.

### Terms and Conditions for the Game Titled “Emoji Challenge” (“**Game 1**”)

#### 4. Game 1 Mechanics

- (a) During the period from 8:30pm to 9:00pm on 16 February 2026, a QR code will be displayed on screen at the Venue. Participants who wish to participate in Game 1 shall be required to be physically present at the Venue during the stipulated time to scan the QR code and answer questions via the designated platform in accordance with the instructions provided by Mediacorp.
- (b) The first ten (10) participants to submit fully accurate and complete responses to the questions (in the order as received by Mediacorp) (the “**Qualified Participants**”) will be selected to proceed to the next round of Game 1.
- (c) From the Qualified Participants, three (3) participants (the “**Selected Participants**”) will be selected to participate in the final round of Game 1, in accordance with the instructions determined by Mediacorp during the Programme.
- (d) Each Selected Participant will be paired with one (1) artiste to form a team. Teams will be awarded points based on correct answers, and points will be accumulated across the rounds of Game 1.
- (e) Teams will be ranked according to their total accumulated points in the Game, and prizes of varying values will be awarded to the teams based on their final rankings.

### Terms and Conditions for the Game Titled “马上发财” (“**Game 2**”)

#### 5. Game 2 Mechanics

- (a) Each participant’s seat at the Venue will contain one (1) goodie bag, which will include one (1) red packet (each, a “**Red Packet**”). Participants are required to open their Red Packet to check the paper slip contained within the Red Packet.
- (b) Four (4) participants whose paper slip contains a designated qualifying message (as announced by Mediacorp during the Programme) will qualify to participate in Game 2 (the “**Selected Red Packet Holders**”).
- (c) The order in which the Selected Red Packet Holders shall participate in Game 2 will be determined by the numbering indicated on the paper slips.
- (d) Each Selected Red Packet Holder must recite a Lunar New Year greeting as instructed by the Programme host in order to qualify to proceed.

- (e) Upon qualification, each Selected Red Packet Holder will be required to select one (1) large red packet from the four (4) performing artistes on stage, which will be labelled “马”, “上”, “发”, and “财” respectively (the “Red Packet Prizes”).
- (f) The Red Packet Prizes shall comprise the following:
  - (i) two (2) cash prizes of S\$500 each; and
  - (ii) two (2) cash prizes of S\$800 each.
- (g) Results will be announced live during the Event.

#### Other General Terms and Conditions

- 6. Mediacorp reserves the right to change the mechanics of the Games at any time in its sole and absolute discretion. The instructions given during the Programme shall prevail in the event of any inconsistency, and the participants shall adhere to such instructions as announced by Mediacorp during the Programme.
- 7. Participants must comply with all instructions, rules and regulations prescribed by Mediacorp for Games. Failure to comply may result in disqualification at Mediacorp’s sole discretion. In such event, Mediacorp reserves the right in its sole and absolute discretion to select another participant to replace the disqualified participant in accordance with the selection procedures for the Games as described above and/or as announced during the Programme.
- 8. Prize Redemption
  - (a) Winners shall be required to strictly adhere to instructions specified by Mediacorp and/or any third party sponsors (if applicable) for redemption of the prize. Without limitation to the foregoing, to the extent applicable:
    - (i) Mediacorp and/or any third party sponsors may request for additional information from the winners for purposes of prize redemption and delivery.
    - (ii) If any redemption deadlines are specified by Mediacorp and/or any third party sponsors, all winners must claim their cash prizes by the stipulated deadline failing which the prizes will be forfeited.
    - (iii) Mediacorp and/or any third party sponsors shall not be liable for any cash prizes which are lost, delayed or damaged in the process of delivery, for reasons beyond its control. All winners will be solely responsible for providing Mediacorp and/or any third party sponsors with accurate contact details, and in the event that any failure and/or delay in cash prize redemption is due to any incorrect or incomplete information provided by the winner, the winner shall fully indemnify Mediacorp and/or any third party sponsors for any losses and/or costs incurred.
  - (b) Cash prizes are not transferable or exchangeable. In the event that a winner, for any reason, does not accept the cash prize, no other form of compensation will be supplied in lieu of that forfeited prize (or any part thereof).
  - (c) Mediacorp and its sponsors reserve the right not to award any cash prizes, or to substitute or alter any of the cash prizes offered. In particular, where any cash prize (or part thereof) is unavailable, Mediacorp and/or any third party sponsors may (but shall not be obliged to) provide an alternative prize, in its sole and absolute discretion. Participants acknowledge and agree that the prizes may be subject to such other terms and conditions as may be imposed by Mediacorp and/or any

sponsors, third party agents and/or contractors engaged by Mediacorp to fulfil the delivery of prizes (if any).

- (d) By accepting a cash prize, each winner accepts full and complete responsibility for their own safety and welfare at all times and, to the fullest extent permitted by law, agrees that Mediacorp and its sponsors shall not be liable or responsible for any risks or damages associated with or arising out of the participant's acceptance of the cash prize. Each participant expressly acknowledges and agrees that Mediacorp and its sponsors shall not be liable to any of the participant(s) for any injury, loss or damage whatsoever or howsoever caused arising directly or indirectly in connection with a Game, including any loss, damage or injury which may be incurred arising from the prizes. A participant (and his/her accompanying guest, if applicable) shall sign such waivers and releases as may be required by Mediacorp, failing which Mediacorp reserves the right to disqualify the participant. Mediacorp shall not be responsible or liable for any misinterpretation or misrepresentation of facts in respect of the prizes offered as published in any media, marketing or advertising materials.
  - (e) Mediacorp and its sponsors and partners accept no responsibility for any tax implications that may arise from accepting any cash prize and all participants shall take sole responsibility for obtaining independent financial and tax advice in relation to any of the prizes won under this Games.
  - (f) In respect of any cash prizes forfeited and/or withdrawn pursuant to these Terms and Conditions, Mediacorp may utilise and/or otherwise distribute such prize in such manner as it may determine in its sole and absolute discretion.
9. By participating in the Games, each participant agrees to take part in any promotional or publicity exercise as may be conducted by Mediacorp in connection with the Games and each participant hereby irrevocably and unconditionally grants Mediacorp all consents and waivers necessary for Mediacorp to record and use the participants' performance(s) and appearance(s) in connection with the Games in any manner as Mediacorp shall in its sole discretion deem fit. Each participant acknowledges that Mediacorp shall be at liberty to publish and otherwise use any recordings made by Mediacorp, including without limitation telephone recordings, audio recordings, video recordings and photographs (if any), for promotional and publicity purposes or any other purposes as Mediacorp deems appropriate (whether now or in the future).
10. Each participant shall make full and honest disclosure of all particulars and information as requested by Mediacorp. Participants understand that submission of any inaccurate, incomplete, false or misleading particulars or information, or wilful suppression of material facts will render the participant liable for disqualification.
11. No obligation will be incurred by Mediacorp or its sponsors by reason of participation in a Game or by reason of anything done or omitted to be done by the participants as a result of or on account of a Game. Mediacorp shall not be liable or responsible for any and all losses, damages, costs and/or expenses (of any nature whatsoever) suffered by any participant arising from any failure or refusal, for whatever reason, to deliver or transfer, whether by Mediacorp or its sponsors, the prize(s) or make good on any promise or offer to the participants.
12. Each participant shall indemnify Mediacorp, its related companies, and their respective officers, employees and agents against any claims, liabilities, damages, loss or expenses (including legal expenses on a full indemnity basis) resulting from any breach of these terms and conditions, or any instructions, rules and regulations prescribed by Mediacorp.
13. Each participant shall be responsible for his/her own expenses incurred by him/her during or in connection with his participation in a Game, and no reimbursement may be sought from Mediacorp.

14. In the event of any actual or suspected fraud, abuse, or breach of any of these rules and regulations by any participant, Mediacorp reserves the right to disqualify him/her from the Games, and any prizes won may be forfeited, withheld or withdrawn.

15. Personal Data

Your personal data will be collected, used, disclosed and/or processed by Mediacorp for the following purposes:

- (a) For purposes in connection with the Games.
- (b) For Mediacorp or its designated representatives or business partners to provide goods and services to you or parties designated by you and matters ancillary thereto.
- (c) To verify and process payment when you purchase goods and services from Mediacorp.
- (d) For verification and record of your personal particulars including comparing it with information from other sources and using the information to communicate with you.
- (e) For research and analysis, including surveys and polls.
- (f) For administration and collection of prizes, including publishing of list of winner(s).
- (g) For publicity and marketing purposes.
- (h) To send you notices, information, promotions and updates including marketing and advertising materials in relation to Mediacorp's goods and services and those of third party organizations selected by Mediacorp.
- (i) To comply with any request from any third party or any order of court or directive from authorities investigating any alleged offence or misconduct or for the purposes of taking legal action against any participant.

For the avoidance of doubt, Mediacorp may share your personal data with a third party in order for Mediacorp to perform the purposes as described above, or for other purposes where we have your consent to do so.

16. By agreeing to these terms and conditions, you:

- (a) consent to Mediacorp collecting, using, disclosing and/or processing your personal data for the purposes as described in the Clause above;
- (b) consent to Mediacorp transferring your personal data out of Singapore to Mediacorp's third party service providers or agents for the purposes as described in the Clause above.

18. In the event of a dispute, Mediacorp's decision is final. No appeals or correspondence will be entertained.

19. These terms and conditions shall be governed by and construed in accordance with Singapore laws.
